Dr. Stanley L. Robbins, a physician and author whose text made the study of diseases come alive for generations of medical students, died October 7, 2003 following open heart surgery at Brigham and Women's Hospital. He was 88.

Summer '03 Meeting in Mont-Tremblant, Quebec, Canada. The site of the summer meeting turned out to be nothing short of superb. Mont-Tremblant in Quebec, Canada, offered scenery and a European-like village setting that was perfect for meeting old friends and learning from one another and the outside invited speakers and guests. Highlights of the meeting were several, including two workshops on working with difficult people, one for Chairs and one for PRODS, led by Bill and Linda Tiffan, consultants from Atlanta. Another highlight was the presentation of the Distinguished Service Award to Dr. Charles Hirsch, Chief Medical Examiner of New York City, for his leadership in Forensic Pathology over many years and particularly for his leadership in New York following 9/11. A modest man, Dr. Hirsch was very grateful to APC for recognizing him and his staff in New York. A number of you told me the overall program was the best ever, with the Thursday AM session, including the Deans' presentations being particularly noteworthy. Finally, we facilitated two interactive sessions, one Thursday late afternoon and one Friday late afternoon, with other major organizations, which were very productive. The Thursday PM meeting was with the pathologist, Col. Renata Greenspan, new head of the AFIP, from whom we learned that plans for cost-cutting within the Institute should not affect the quality of their service to academic pathology. The APC promised our help in the future should they need our support. The Friday meeting was with several representatives of the College of American Pathologists where we established plans for enriching our interactions with one another. One outcome was mutual recognition of how many APC members are also CAP members and that many APC members served on CAP committees.

Summer '04 Meeting in Mont-Tremblant. I hope that all of you will plan on putting next summer's meeting on your calendars and plan to be with us; the inclusive dates are July 21-24, 2004. The special program focus will be undergraduate medical education, which means all of Thursday will highlight this part of our academic mission. We hope to raise issues related to Pathology's involvement in the integrated medical student curriculum, measuring competencies in medical students, and enhancing the views that medical students develop about the discipline of pathology. We also hope to leave you with some exciting new ideas to take home. As always, special programs related to residency training issues will be developed by PRODS and for department administration by PDAS. Furthermore, we plan two sessions of a workshop on financial management being organized by Ralph Green, one on Wednesday for Chairs and one tentatively on Thursday for PDAS. We will make available some openings for others who might be attending on Wednesday and Thursday to attend the workshops. We also plan to host another "new chairs" luncheon Thursday noon and program special research issues for the morning of Friday the 23rd and "Hot Topics" for the morning on Saturday the 24th. As plans for the meeting shape up after the Winter Council meeting, we will post the preliminary schedule on the Webpage at http://www.apcprods.org.

Logo, Vision and Mission Statements. If you have visited our webpage recently, you saw our new Logo, which was developed by our past president Jerry Garvin's daughter, Courtney Garvin. She offered several ideas to the Council, we picked our two favorites, and you voted this past summer. I hope you are pleased with the result. Council is also confident (based on no negative concerns voiced follow the announcement in the Spring) that you are satisfied with the APC vision statement of "Promoting Excellence in Academic Pathology" and our mission statement, both also clearly shown on the Webpage.

APC Research in Education Group (REG). Vinay Kumar, who chairs REG, and other members of REG are currently planning an RFP to award funds to one or two programs that should advance education in pathology. You should be hearing more about this initiative soon.

Winter Council Meeting. The APC Council will hold its annual meeting in January to plan the summer meeting, approve the annual budget, review proposed changes to our ByLaws for your vote in the summer, review and possibly revise its long term strategic plan and then develop its 2004 Action Plan. Secretary-Treasurer's Report: Summer Conference Robert L. Reddick, MD

The Annual meeting of the Association of Pathology Chairs was held in Mont-Tremblant, Quebec, Canada on July 23-26, 2003. The meeting was sponsored by the APC, PDAS, and PRODS. The overall theme of this year's meeting was Making a Margin for the Mission: The Business of Pathology. The leadership workshop for APC and PRODS was led by Bill and Linda Tiffan on the topic of Dealing with Difficult People. Evaluations of this session were highly favorable and suggestions to include this type of workshop in future meetings were made by many who were involved in these sessions. The morning session on Thursday was entitled "Making a Margin for the Mission: The Business of Pathology" and consisted of short presentations by deans and chairs of Pathology, moderated by Dan Sedmak. The main theme centered on funding issues related to the provision of clinical services, the cost of education, whether research can pay for itself, and funding in academic medical centers. These talks were followed by a panel discussion and open discussion with the attendees. The major outcomes from this session were for departments to develop creative solutions to the funding of missions, focus on accountability of faculty and faculty retention, manage overhead costs, perform trend analyses to assist in planning and corrective actions, and to develop liaisons with local and national funding sources. Eleven APC/ PRODS/PDAS workshops were available for participation for the attendees. Topics ranged from evaluations of resident competency to measures needed to adequately manage a department of Pathology, which included managed care contracting, new faculty, shared resources, and budget cuts. Workshop summaries may be viewed on the APC website. The Friday, July 25, 2003 morning session returned to the business of the research mission and was moderated by George Michalopoulos. Presentations were provided by invited speakers who discussed new innovations in diagnosis and treatment of diseases through the use of proteomics and mass

spectrometry. Emmanuel Petricoin discussed the future of proteomics and mass spectrometry in cancer screening, diagnosis, and prognosis. The use of serum in proteomics and mass spectrometry was also discussed as a future application in the diagnosis and prognosis of malignant tumors. Platform talks related to trends in research financing and technology transfer were also presented in this session. Some potential future concerns were raised regarding research financial trends and included loss of champions in Congress, increased governmental oversight, federal budget deficits, and state budget woes, especially for public funded institutions. The PDAS meeting on July 25, 2003 on How to Get Done What We Must Get Done concentrated on communications with Chairs and residents, faculty and departmental management issues, and billing issues. The latter included Part A Contracts, compliance issues, and billing.

Hot Topics in Pathology On Saturday, July 26, 2003 the Hot Topics in Pathology session was presented and moderated by Mary Lipscomb. A panel discussion was held which focused on the relationship of departments of Pathology and institutional interdisciplinary research. The question posed was whether departments of Pathology should be the leaders in institutional centers, program project grants, and SCOREs. Avrum Gotlieb provided an overview of academic pathology in Canada and commented on the similarities and differences between pathology departments in the US and Canada. Dennis Padget presented new information on billing practices and cautioned the group to use the appropriate wordings on reports to facilitate ease of billing. Carole Pillinger and Jack Humphrey discussed HIPAA and the effect that it has had on report generation, reporting, and billing. The effect appears not to have affected the day-to-day operations but have produced new compliance regulations in some institutions.

Keynote Address The Keynote Address was delivered by Robert S. Greenburg from UCLA. The title of the talk was "Consortium for International Healthcare Development: A model for Volunteerism". The speaker was introduced by Dan Sedmak as a leader in advocating for care and involvement in the international care of patients with cervical cancers. Dr Greenburg was described as an advocate for health care in the third world who utilized his talents in promoting volunteerism for western physicians. A major focus was the involvement of pathologists in third world patient care activities and the lack of adequate pathologist involvement and coverage in health care areas with high rates of female genital cancers. Dr. Greenburg pointed out that the pathologist was essential in the complete care of these patients who presented with cancers that would, more than likely, be treated successfully in the United States. There was a cry for both practicing pathologists and residents in pathology to become involved in the care of these patients. Dr. Greenburg used a pictorial supplement in his talk. He presented photographically the "look" of desperation in the eyes of those associated with the cancer patient suggesting that it was the entire family that suffered from what happened to one member of the family. He completed his talk with three short sentences - We shall return, We love you, and We are family. The emphasis was on humanism, care, and follow-up patient care in areas of critical needs. However, a

most enlightening ending statement was "*call from the pathologist, you've got slides!!* stating that the pathologist was on board and participating in the programs to help turn desperation and loss of hope into cures.

APC Distinguished Service Award This award is given to an individual who has made a significant contribution to academic pathology in research, in education or in advancing the discipline of pathology in the medical community and to the public at large. The recipient of the distinguished service award for 2003 was Charles S. Hirsch, M.D. Dr. Hirsch is the Chief Medical Examiner for the City of New York. His department was responsible for the forensic evaluation of the victims of the tragedy at the World Trade Center towers on September 11, 2002. He graduated from the University of Illinois College of Medicine, Chicago in 1962 and has been the Chief Medical Examiner in New York City since 1989.

The PDAS listserv continues to be quite active with many requests for information. For example, there have been recent requests for information on research space allocation principles, pathologist's assistant salary levels, staffing incentive programs, productivity measures, Part A negotiations, IRB issues, to name a few. We encourage all members to utilize this resource. We also appreciate everyone adhering to our policy of "strictly business" when using the listserv.

We should all give a big applause to Sandi Jaros, her systems administrator and the Survey committee for all their hard work on the APC Department Survey. As Sandi, Chair of the Survey Committee writes: "Fifty departments of pathology participated in the first APC-sponsored survey on initial departmental profile. The results showed that most departments are a hybrid of basic science and clinical departments and are associated with a teaching hospital of 560 beds. The average department performs 113 autopsies, handles 31,336 surgical specimens, 3,400 pap smears and 1,850,000 clinical laboratory tests per year. The typical Department of Pathology consists of 34 MDs or MD/PhDs and 14 PhDs. The faculty efforts are divided into administration (12%), teaching (19%), clinical service (34%), and research (26%). The budget of our average department is derived mostly from Part B activity followed by research dollars. The average department has 18 residents, 8 postdoctoral fellows, and 10 graduate students. As this survey was our first attempt to define departments of pathology, we are soliciting your ideas on ways to enhance the survey and to improve institutional participation. The focus of the next survey will be on undergraduate medical education and research. We will again have a \$100 random prize drawing for participants. The survey will be valuable to all of our departments if there is information that is useful to you. We desire your input to make this a successful Adventure for the APC membership."

Lastly, I warmly thank all the participants from PDAS who co-presented in the Workshop sessions and/or gave presentations to the PDAS. Your willingness to volunteer and contribute your knowledge and experience greatly enhances the effectiveness of both the APC and the PDAS.
